What we've been up to...

On 19 September ABE re-sent our earlier letter to the General Manager requesting a copy of council's approval for the clearing of community land at Clarke Street Broulee and seeking clarification about the future of this site. The response we eventually received from Council did not address all of our concerns, so it is still unclear whether due process was followed in permitting a private developer to clear the land to create an Asset Protection Zone for development on adjoining land and how the remaining land will be managed.

On 25 October ABE wrote to Council seeking details about their \$4.2 million Real Estate Development Fund referred to in the agenda papers for the final Council meeting. We asked how this fund fits into Council's governance structure, what functions it is designed to perform, where it sources its funds from and what criteria are used to disburse these funds.

ABE presented at two Public Forum sessions. On 12 October we spoke about Council's failure to act in a timely and appropriate manner in relation to the gate on Coopers Island Road and land clearing at Clarke Street Broulee. On 26 October we spoke about the 96 lot subdivision on Turnbull's Lane and the Dalmeny Land Release Area both of which have significant implications for the management of public assets in our shire.
